- 3.7 The Agency is expected to apply for general agreement with the MOLSA in 15 days time after receiving the authorization certificate.
- 3.8 Immediately after registration to employ **Medical professional, Baby care takers** and Administrative personnel's to run the activities of the Agency & inform the same to MOJ.
- 3.9 Produce to MOJ lists of employees with their CVs and regularly inform changes taking place.
- 3.10 Produce an authenticated **annual assessment** report of the regulatory organ from its country of origin.
4. The Ministry may, in exercising of its powers under the laws and for good cause, revoke the certificate on any time. With out limiting the generality of the foregoing statement, non-observance of the above mentioned statement and conditions of Authorization or the Code of Conduct of Agencies, 2003 shall constitute good cause for revocation of the Certificate.

STATEMENT AND CONDITIONS

The statement and conditions here on are an integral part of Authorization No **2735** issued on **July 2, 2006** in favor of **International Adoption Guides Inc. (IAG)** (here in after referred to as the "Association".)

1. AUTHORIZED PROGRAM AND ACTIVITIES:

The Association being foreign organization shall:-

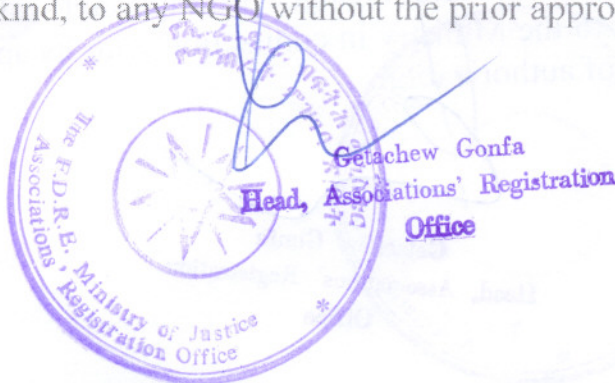
Without prejudice to the restrictions specified under Article 2 here of is authorized to undertake the following:-

1.1 **To carry out inter country adoption.**

2. RESTRICTIONS: The agency is restricted from:

- a/ Providing financial and material support to political parties or groups.
- b/ Involving in any commercial or in any profit generating activities.
- c/ Working with unregistered local or foreign NGOs.

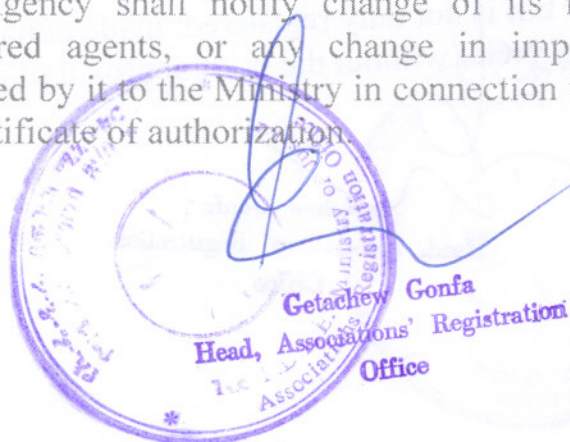
Further more **International Adoption Guides Inc. (IAG)** shall not have any formal or informal contact or relationship with any organization which claims to be an NGO but is not duly registered; made donations or grants in cash or in kind, to any NGO without the prior approval of the MOLSA.

3. CONDITIONS

- 3.1 The relevant provisions of the Civil Code of Ethiopia (1960), the family Law of Ethiopia (2000) and the Association Registration Regulation 1966, as well as the code of conduct of agencies, 2003 shall apply to and observed by the agencies.
- 3.2 Pursuant to the provisions of Article 13 of the Association Registration Regulation Annual activity and audit reports shall be submitted to the association's registration office of the Ministry of Justice. In addition to meeting the requirements of the Associations Registration Regulation, such reports should be in sufficient detail to inform concerned authorities of the FDRE and the public about the association's purposes, the activities it is undertaking in Ethiopia, the beneficiaries, client(s) and other beneficiaries it is serving, sources of its funding and how its funding is expanded.
- 3.3 If new objectives/activities different from the authorized activities are intended, proposals relating to this shall be submitted to the Ministry for approval prior to implementation.
- 3.4 Any application for work permits of country representative or deputy shall be submitted to the Ministry for consideration.
- 3.5 The Agency should declare immediately any donation or grant, in cash or in kind, received by it for its activities in Ethiopia to the Ministry and to all concerned governmental authorities.
- 3.6 The Agency shall notify change of its registered address, registered agents, or any change in important information provided by it to the Ministry in connection with its application for certificate of authorization.
